A Resolution has been adopted by the City Council of the City of Spokane, Washington, on July 20, 2020, in the matter of the proposed vacation of:

North half of Rosewood Ave. between the east line of Helena St. and 25 feet east of the west line of Lot 17, Block 27 of the plat of Gunn's Addition, as requested by Jon and Nicol Whipple.

*The City Council has set the time and place for Hearing on said proposed vacation for Monday, September 21, 2020, at 6:00 p.m. in the Council Chambers, City Hall, 808 West Spokane Falls Boulevard, Spokane, Washington (entrance on Post Street).

***Note:** Pursuant to Governor Jay Inslee's Eighth Updated Proclamation 20-28.8, dated July 31, 2020, all public meetings subject to the Open Public Meetings Act, Chapter 42.30 RCW, are to be held remotely and the in-person attendance requirement in RCW 42.30.030 has been suspended until at least through September 1, 2020. In-person attendance is not permitted at this time. As the September 1 date approaches, the City of Spokane awaits further direction as to whether there will be an extension of this date. Until further direction is received, it is possible the September 21, 2020, City Council meeting will be held virtually, with public comment being taken virtually. If the September 21 City Council meeting is held virtually, a notice containing call-in information will be included with the posted September 21, 2020, City Council Agenda packet. 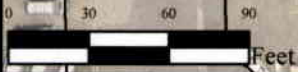
